This monograph contains the 12 presentations of a conference on peacekeeping held in May 1995 at the Pearson Peacekeeping Centre. This conference was sponsored by the Centre for International Relations (Queen's) and the Institut für Friedensforschung und Sicherheitspolitik (University of Hamburg). The chapters deal with such subjects as trends in German foreign and

domestic policy towards peacekeeping, a US assessment of the costs of armed intervention, the use and misuse of airpower in the former Yugoslavia, intelligence support to peacekeeping and Canadian initiatives to enhance the UN's ability to deploy peacekeepers in a timely fashion, among others.

The issues explored at a conference in Japan cosponsored by the Canadian Embassy and the Pearson Peacekeeping Centre in November 1996 include: the changing face of peacekeeping; the legal framework of modern peacekeeping from the Japanese perspective; military and civil police operations in modern peacekeeping; humanitarian and human rights concerns; a comparison between the peacekeeping missions deployed to Cyprus and the former Yugoslavia by officers who served there; the foreign policy aspects of peacekeeping and an examination of the threat posed by anti-personnel landmines.

It is an inspiring tribute to the faith and endurance of people who, against the odds, believe democracy will change their lives and society for the better.

Above all, it is a book of and about hope; a poignant reminder to those of us in developed democracies of the privileged circumstances under which we live and our great responsibility to protect and nurture the democratic process which has given rise to lives of freedom and hope.

In 1995, the Government of Canada presented a study on ways to enhance the UN's capability to the United Nations General Assembly to project peacekeeping forces more quickly to areas of strife. This book contains the full text of a number of presentations from the three conferences which were the basis for that study. The presentations fall into four main categories: Statements by Canadian Government Officials; The need for a Rapid Reaction Response; Lessons from Other Organizations and Case Studies; and The Vanguard Concept. While the first two sections set the conceptual stage, the third provides the benefit of practical experience in places such as the former Yugoslavia, Namibia and with NATO's own Rapid Reaction Corps. In the final section, the merits and drawbacks of the "vanguard" concept are examined.

Between 1986 and 1988, Peter Jones (now with the Stockholm International Peace Research Institute) compiled and annotated bibliography of some 244 books and articles on peacekeeping, which was published by Ronald P. Frye & Company in 1989. This volume, which spanned over thirty years of material on the subject, was quickly recognized by many as an excellent reference tool. In the few years after the bibliography was first published, the face of peacekeeping changed and with it followed a deluge of literature on subjects ranging from the humanitarian aspects of peacekeeping to the revival of the concept of a UN standing army. This bibliography picks up where its predecessor ended. Featuring over 450 entries that cover the period from 1988 until 1996, this volume provides informed and insightful commentary on articles and books which reflect the evolving and increasingly interdisciplinary nature of modern peacekeeping. It is highly recommended as an invaluable resource for peacekeeping researchers, academics and those who need to have a handy reference guide to the literature of this tumultuous period in conflict resolution and international relations.

Derived from the author's diary written while in the Gulf War, as well as his recollection of conversations with the members of the Multinational Mine Counter Measures Group, Desert Sailor is an entertaining and highly informative first-hand account of a little known yet extremely hazardous aspect of the Coalition effort during the Gulf War: the finding and clearance of Iraqi naval mines and the aerial laying of mines by the Coalition. Both a hazardous to the Coalition fleet as well as commercial shipping, the threat posed by "the poor man's naval defence" became all too evident when first the USS Tripoli and later the USS Princeton struck Iraqi mines, causing significant damage to both vessels. Complete with several pictures and maps, as well as appendices on the development of mine warfare and a glossary of terms, Desert Sailor is a personal recollection that is sure to be enjoyed by both the interested public and the military professional.

This is a book about the establishment, implementation and management of United Nations peacekeeping operations, with particular attention to the role played by the Security Council and the Secretary-General. The aim is not merely to review the conduct of past and present operations but to suggest how future operations might be made more effective. Such a process of evaluation and recommendation is necessary for at least two reasons: to enable UN peacekeepers to learn from past successes and avoid past mistakes; and to make UN peacekeeping more responsive to and reflective of the profound shifts in the international scene since 1945 and especially since the end of the Cold War.

General Rikhye's work helps to put the purpose and the direction of the United Nations into perspective. From his knowledge and experience, he writes about learning from the past and the present to plan for the future.

For the purpose of this book, the Albanian refugee emergency of 1999 is treated as a unique, yet fundamentally-linked, event resulting from the military conflict occurring at the time in the Federal Republic of Yugoslavia (FRY), and the overt threat of a continuous and bloody "ethnic cleansing" campaign from the FRY leadership. This conflict, generally termed by the international media as the "Kosovo Crisis," planted the seeds of the Albanian refugee emergency in the spring of 1998 when Serbian forces, operating in the Yugoslav province of Kosovo, launched a major offensive against ethnic Albanian combatants to gain control of the southwestern border region of the province. A year later, an escalation in the assaultive ethnic cleansing actions of military and paramilitary armies against Kosovar Albanians led to a most extraordinary refugee event within the neighboring Balkan country of Albania. This book is a capsulized presentation of the Albanian government's response to that event. It is the story of Albania's EMG.

This book is designed to provide career diplomats and potential military negotiators with the information they must understand if they are to help negotiate the military aspects of agreement ending a civil war. There are numerous works in print that concern negotiations in general, but when in 1992, author Anthony Marley was sent, on behalf of the United States Government and Department of Defence, to Rome to participate in the peace negotiation to end the civil war in Mozambique, he had expected to find studies concerning the military components of a peace agreement. To his chagrin, no such study had been written. So, he did the research and prepared a "checklist" of what he anticipated would be negotiated. Subsequently, he had the opportunity to participate in peace negotiations in Ethiopia and Rwanda, and in pre-negotiations in Liberia and Sierra Leone. Over the course of time, he utilized and modified the checklist which he also used as a reference tool during negotiations. This body contains the study drawn from that original checklist, with supporting details and anecdotes added.

Peacekeeping by Proxy is a term, devised by the Pearson Peacekeeping Centre. It refers to a situation in which the Member States of the United Nations Security Council, which has "responsibility for the maintenance of international peace and security," decides, for some reason, that they cannot establish a needed peacekeeping mission. In that case, the Council gives its proxy to an individual country, a group of countries or an organization. With this proxy and linked to the UN by an authorizing resolution, the acceptor of the proxy organizes and carries out the operation.

Yes, the Canadian Army was involved in the Holocaust, so was every soldier in the Allied Armies. If they had not fought and won World War II in Europe, The War Against the Jews would not have ended. There would have been no survivors. On behalf of all 861 remaining inmates of Westerbork, we hope that this book will be an educational and memorial document of Canada's military role in World War II in memory of all veterans who fought and paid with their life for this victory.

Until the Somalia and Bosnia missions in the 1990s, the UN Operation in the Congo (ONUC) was the most violent UN peacekeeping operation ever conducted. Now, after more than 30 years, controversy still reigns over whether or not the UN overstepped its mission in the Congo from peacekeeping, under Chapter VI of the UN Charter, into enforcement, under Chapter VII. Much of this book is devoted to considering that question. The author describes the genesis and mandate of ONUC and dissects the various mandates given to the operation, especially the legal arguments about which parts of the Charter were applicable. Conclusions are drawn, including the lessons learned for use of force in future peace operations.

### **Nationbuilding in East Timor**

This publication brings together some of the defining papers given at the seminar on Nationbuilding in East Timor, held at the Geographical Society in Lisbon, in June 2001, and hopes to contribute to identifying the new challenges of nationbuilding.

The events of 11 September 2001 have given new meaning to the work of the seminar *Nationbuilding in East Timor* that took place the previous June. At the time, the organizers were preoccupied with the birth of a new nation, East Timor, a somewhat isolated and distant country. After 11 September, the concept of nationbuilding was globalized.

Since nationbuilding was not a common word or accepted political practice before 11 September, there exists no pool of experts. There are no manuals on nationbuilding. However, a few things on the East Timorese experience were brought to light during the seminar.
